The Capital City Lawyers Association (CCLA) is seeking applicants for its Spring 2023 stipend which is awarded to two law students annually.

CCLA is the African-American Bar Association in Raleigh, North Carolina. CCLA's mission is to improve the quality of life in our community through education, service, and scholarship. CCLA will award two spring stipends to deserving law students who demonstrate a commitment to practicing in the Triangle area and using their legal training and skills to benefit low-income and/or traditionally underserved communities.

**Qualifications**: To be considered for the spring stipend, the applicant must be a 2L, 3L, or 4L student attending either North Carolina Central University School of Law, UNC School of Law, Campbell University Norman Adrian Wiggins School of Law, Wake Forest School of Law, Elon School of Law, or Duke University School of Law who exemplifies the mission of this organization. Active participation in the Black Law Student's Association (BLSA) is preferred.

**Application Process**: To apply for the stipend, applicants must submit: (1) a completed Application, (2) a current resume, (3) an offer letter for unpaid summer employment **or** a letter from the applicant certifying that he or she will be sitting for the February 2023 North Carolina Bar Examination and will not be reimbursed by his or her employer for expenses related to the bar exam/bar study, and (4) a one page personal statement addressing the following questions: (i) how do you intend to use your legal training and skills to benefit low-income and/or traditionally underserved communities within the Triangle area and (ii) how does your background demonstrate your commitment to assisting low-income and/or traditionally underserved communities?

**Application Deadline**: The application deadline is December 31, 2022.
