Founded in 2018, the Keck Graduate Industry Fellowship Program aims to provide exceptional biopharmaceutical industry training for Doctor of Pharmacy (PharmD) graduates with a broad exposure to the areas fundamental to drug discovery, development, and commercialization. This program will prepare for a career in the biopharmaceutical industry by focusing on developing a deep understanding of how companies operate.

Requirements:

A successful candidate must be a PharmD graduate from an ACPE accredited institution. Substantial background knowledge in psychiatry is a plus. All candidates must have the right to work in the USA. The fellowship will provide comprehensive practical hands-on biopharmaceutical training and foster an environment of learning with a leading biopharmaceutical company. The collaborative environment will offer the fellow an enduring network and exposure to grow exceptional skills.

Job Duties:

1st Year – US Medical Affairs (US Medical Director's Office)

- Participate in the medical review of promotional and non-promotional materials.
- Provide guidance and input in the development of medical slides and materials.
- Represent Biogen at medical congresses by engaging with key medical experts (KMEs), attending poster/oral presentations, and obtaining insights.
- Serve as a medical expert and provide disease state training and clinical development program training to various cross-functional teams as requested.
- Participate and present in various departmental meetings.
- Analyze insights and provide summary insights at cross-functional strategy team meetings.
- Assist Medical Directors in advisory board planning and execution, including identification of KMEs, planning objectives and content, serving as a presenter, etc.
- Collaborate cross-functionally with various other teams, which may include Regulatory, Legal, Clinical Development, Patient Advocacy, HEOR, Market Access, Global Medical Affairs, Global Scientific Communications, Medical Information, US Field team, etc.

2nd Year – Medical Science Liaison (MSL)

- Participate in Foundational Medical Training to be certified as an MSL.
- Serve as a field medical expert and provide scientific exchange (eg, disease state training and clinical development program data) to KMEs on MSL ride-alongs.
- Be trained in engagement planning, KME mapping, territory management and the art of developing and fostering relationships with KMEs.
- Engage with KMEs in various forums (eg, 1:1s, medical forums, congresses) to gather informative insights.
- Represent Biogen at congresses by staffing the medical booth, engaging with KMEs, attending and summarizing poster/oral presentations, and obtaining insights.

- Participate in journal clubs to ensure therapeutic knowledge is current.
- Analyze field insights to present to internal key stakeholders.

KGI Requirements:

- Learn and comply with regulations set by KGI, Biogen, and national/global regulatory agencies.
- The Biogen-KGI Fellow will have academic responsibilities at the Keck School of Pharmacy and Health Sciences which may include precepting students, publishing abstracts or posters, and representing the fellowship to pharmacy students.
- The Biogen-KGI Fellow must attend biweekly fellows conference calls and semi-annual Professional Development Days.

Desired Skills:

- Strong work ethic and sense of adaptability to changes in work goals or environment. Candidate must demonstrate ability to take direction and work both independently and as part of a team.
- Pro-active approach to assigned responsibilities, with responsiveness to prioritize according to needs of the project.
- Reliability, strong attention to detail, accuracy and effective organizational skills in planning and overseeing multiple parallel short- and/or long-term projects.
- Experience with gathering, processing, analyzing and critically evaluating large volumes of data.
- Commitment to communicating respectfully and effectively within the team.
- Demonstrated strong verbal and written communication skills.
