

### What is NCAP? Cont.

The North Carolina Association of Pharmacists

- 140+ years of service to North Carolina
- Fosters growth and provides education opportunities to students across the state
- Continued advancement beyond graduation enabling pharmacists to practice at the top of their license

### Advocacy

- Long history of advocacy for pharmacy and healthcare at the state and federal level
- Successes and endeavors
  - Expanded the role of immunizing pharmacist in NC
  - Helped develop and pass the Clinical Pharmacist Practitioner Act
  - Developed and passed the "Pharmacists Improve Public Health Needs" bill
    - Pharmacists can administer LAI's, any self-administered injectable, dispense NRT and certain contraceptives without a prescription, and more
- NCAP continues to fight for fair reimbursement for pharmacy services

### **NCAP for Pharmacists**

- New Practitioner Forum
  - Members are pharmacists in the first 7 years of their career
  - Networking, leadership opportunities,
  - Collaboration and mentorship opportunities with the SPF
- Additional training
  - LAI, Opioid stewardship, Hormonal contraceptives, PEP therapy, etc.
- Continuing education
  - Offers many CE opportunities throughout the year both live and on-demand
- NCAP Pharmacy Convention
  - Premiere event for NC pharmacists

### **NCAP for Students**

- Student members are a part of the Student Pharmacist Forum (SPF)
- Leadership team consists of representation from all four schools and meets throughout the year.
  - Chair rotates between schools; UNC, HPU, Wingate, and Campbell.
  - Coordinates events both virtual and in-person
